Row A: 12m deep

3.5m frontage	£70.00	includes 1 vehicle & 2 personnel passes
7m frontage	£140.00	includes 1 vehicle & 2 personnel passes
10.5m frontage	£210.00	includes 2 vehicles & 3 personnel passes
14m frontage	£280.00	includes 2 vehicles & 4 personnel passes
21m frontage	£420.00	includes 3 vehicles & 6 personnel passes

Row C: 9m deep

3.5m frontage	£75.00	includes 1 vehicle & 2 personnel passes
7m frontage	£150.00	includes 1 vehicle & 2 personnel passes
10.5m frontage	£225.00	includes 2 vehicles & 3 personnel passes
14m frontage	£300.00	includes 2 vehicles & 4 personnel passes

Sites will be allocated on a first come basis.**

Admittance to the Rally Field will be strictly on a prepayment basis.

Schedule of Conditions applying to all traders during the period of the Cumbria Steam Gathering.

1. The Society reserves the right at all times to refuse admittance to any Trade Stand Exhibitor.
2. Admittance to the Event Rally Field will be strictly on a pre-payment basis: Entry will be refused if this instruction is not complied with.
3. All admission of Trade Stands, Traders and their staff will be by a special Passes issued by the Society and valid for the event days only.
Only vehicles displaying the appropriate passes will be allowed access on to the Rally field, passes will be issued and only holders of these passes will be allowed access through the gates.
The gates will be closed from 23.00hrs until 07.00hrs the only exception being emergency vehicles.
4. Acceptance by the Society of a firm reservation or pre-payment of rental in no way confers any rights whatsoever to the Renting Trader and in no way modifies these Conditions.
5. Cancellation of pre-payment bookings will be reviewed upon the merits of each case.
6. The site must be left in a clean and tidy condition. Glass, tins, string, plastic wrappings and all other refuse must be placed in the containers or skips or placed in other suitable containers for ease of disposal.
7. Mock auctions by any trader will not be permitted. Traders in breach of this condition will be expelled from the Rally-Field.
8. All Trade Stand exhibitors must follow the instructions issued by the Society or their delegated representatives.
9. All Traders must be covered for public liability and products liability insurance and will indemnify the Society for any such claims for loss, damage or injury arising from any incident howsoever caused.
10. All Traders must have adequate fire fighting equipment which must be available for inspection by the Society's Safety Officer.
11. Traders may only sell items specified on their booking form.
12. Copyright - The words 'Cumbria Steam Gathering' and logo of the Cumbria Steam & Vintage Vehicle Society Limited are copyright and may not be used without prior written consent of the Society.
13. No sub-letting of the allocated sites is permitted.
14. The use of Public Address systems is forbidden.
15. All dogs must be kept on a leash at all times and be under proper control.
16. The allocation of sites and positioning of Stand space will be entirely at the discretion of the Society, although every endeavour will be made to meet any request made by traders and regarding the position of his stand.
 - (a) Traders booking open space must apply and pay for sufficient space for all stays or guy-ropes required for any building, tent or caravan to be erected on the space.
 - (b) Boundaries of sites will be marked and in no circumstances will traders be allowed to occupy a larger space than that allocated to them.
 - (c) Traders staff must confine their sales activities to the area of their stand and must not use the avenues to solicit business.
17. All electrical generators, wiring and appliances should have a current inspection certificate in accordance with the I.E.E. Regulations and these will be inspected by the Society's Safety Officer who has the authority to prohibit the use of unsafe electrical generators, wiring and appliances.
18. **Traders are not permitted to sell any item which issues a projectile ie. crossbows, bows and arrows. Guns, replica guns, hand guns, and weapons are not permitted to be sold.**
19. All traders should acquaint themselves with Current Legislation and ensure that their activities are carried out in accordance with the Statutory Provisions.
20. Any trader who is in contravention of these conditions will not be permitted to trade and will be removed from the Rally field with no recompense.
21. The riding of cycles is forbidden and a 5 m.p.h. speed limit is in force from 25th July to 1st August.
22. In the event of a dispute the Event Organisers decision is final.

INSTRUCTIONS FOR TRADE/AUTOJUMBLE/CRAFT EXHIBITORS/CATERERS

1. THE SITE is situated on CARK AIRFIELD, FLOOKBURGH, GRANGE-OVER-SANDS, CUMBRIA LA11 7LS and is reached by taking the A591 from Junction 36 on the M6 Motorway and then after 3.5 miles turn left on to the A590 signposted Barrow. Heavy vehicles should proceed along the A590 to the village of Haverthwaite and then turn left and proceed on the B5278 through Cark village to Flookburgh. Light vehicles should turn left off the A590 at the first roundabout and proceed through Grange-over-Sands on the B5277 to Flookburgh. The route will be signposted

**THE SITE IS UNAVAILABLE UNTIL 10.00hrs THURSDAY 26TH JULY
AND MUST BE VACATED BY NOON MONDAY 31ST JULY**

2. PASSES:- You are entitled to vehicle pass/passes and personal identification passes. These will be issued to you, by the gate/security staff. They will only be issued on production of this acceptance letter. The vehicle passes must be displayed in the vehicle windscreen and the personal identification passes worn to enable access on or off the Rally field. Additional vehicle passes could be available by applying to the Trade Stand Organiser in writing, enclosing a S.A.E.
3. Publicity material for the Event is enclosed; please display it prominently to aid the general publicity plans.
4. Please Note that Any Trader who Trades outside their designated/allotted site will not be permitted to trade and will be removed from the Rally field with no recompense.
5. Non-exhibit vehicles can only remain on your allocated site. All vehicles parked incorrectly will be removed by the stewards.
6. TRADE EXHIBITS are required to be sited on the Rally Field no later than 09.00hrs on Saturday, and trading must commence by 10.00hrs on both days. Access to the Rally Field will be available from 10.00 hrs on 26th July.
NOTE: There will be no access on to the Rally Field for vehicles between 23.00 hrs and 07.00 hrs.
7. ON ARRIVAL AT THE RALLY FIELD you will be directed to your allocated place. Please follow the Stewards instructions exactly. With such a large entry of exhibits for the Stands everyone can be fitted in properly if the predetermined plan is carefully followed.
8. The use of cycles by ANY person is forbidden.
9. CLEARANCE OF SITE - The site must be cleared by noon on Monday 31st July. You are required to leave your space clear of rubbish. Refuse disposal facilities will be provided in the form of waste bins and larger skips. Please use these facilities, your co-operation will be much appreciated.
